a) Our products are guaranteed to be free from adulteration or misbranding, fully compliant with the Safe Food for Canadians Act (SFCA) and the Safe Food for Canadians Regulations (SFCR).

b) We hold a valid SFCR License (# 9XL367T8) issued by the Canadian Food Inspection Agency, as well as an FDA License (# 18046531092) for our products, certified by Pooja Dehy Foods Pvt Ltd.

c) All products are produced in strict compliance with Good Manufacturing Practice guidelines and are packaged in food grade packaging materials under the most hygienic conditions.

d) All ingredients used in our products adhere to Health Canada's guidelines for pesticides, heavy metals, and chemical residues, with no exceedance of the Maximum Residue Limits as defined under the Pest Control Products Act. Additionally, no chemical is present at levels exceeding 0.1 ppm, unless otherwise listed.

e) We have implemented a comprehensive Supplier Approval procedure to ensure that our suppliers are compliant with all food safety requirements and have their products regularly assessed for any vulnerabilities to food fraud or adulteration. We keep a constant eye on news media and reports on spice adulteration to remain vigilant.

f) All incoming raw materials are inspected thoroughly for any evidence of tampering or adulteration.

g) Our product Specification Sheets include all relevant details such as country of origin, method of sterilization (if applicable), ingredient declaration, chemical and physical attributes, microbiological specifications, nutritional data, allergen status, recommended shelf life and storage conditions. We promptly notify our customers in writing of any changes regarding ingredient declaration, addition, or elimination of an allergen, or increases or decreases of sulphite levels.

h) Our products undergo rigorous testing, including analytical and microbiological testing, which is conducted by approved AOAC, HPB, or Food Chemicals Codex methodology on representative samples of lots received from our suppliers and shipped to our customers.

i) We ensure that our products are stored and transported under conditions that preclude chemical, microbiological, rodent and insect infestation, foreign matter, and general filth contamination.

 j) Our management team is fully committed to the development, implementation, and effective maintenance of our Hazard Analysis and Critical Control Points (HACCP) system, which is reassessed at a minimum annually.
Additionally, our allergen control program is implemented with procedures in place to prevent cross-contamination of the product with an allergen does not present in the product but manufactured on the same line or present in the same warehouse. All allergens and sulphites are identified on packaging labels.

k) We have written sanitation Standard Operating Procedures (SSOPs) in place, and a Master Cleaning Schedule is implemented to ensure cleanliness and hygiene.

I) In the unlikely event of a recall, we have established recall procedures and an effective traceability system that is tested at a minimum annually. We provide regular employee training programs, including food safety and food defense training, to all staff on the first day of employment and thereafter at a minimum annually.

m) Finally, we are proud to inform you that our facility is certified to Brand Reputation through Compliance Global Standard (BRCGS) with annual recertification (Pooja Dehy Foods Pvt Ltd.).

This Letter of Guarantee is effective for one year from the date of receipt and will require re-issuance each year thereafter. We will inform you of any changes in the interim to the Letter of Guarantee.
